The undersigned, for the purpose of amending the Articles of Incorporation of GRACE COMMUNITY SCHOOL OF N. FORT MYERS, INC., a Florida corporation, hereby makes, acknowledges, and files the following amendment to its Articles of Incorporation, pursuant to Section 607.1006, Florida Statutes.

FIRST: The Articles of Incorporation of GRACE COMMUNITY SCHOOL OF N. FORT MYERS, INC., were filed with the Florida Department of State on January 2, 2003, and were assigned Document Number P03000000463.
