**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
GRACE COMMUNITY SCHOOL OF GOLDEN GATE III, INC.**

The undersigned, for the purpose of amending the Articles of Incorporation of GRACE COMMUNITY SCHOOL OF GOLDEN GATE III, INC., a Florida corporation, hereby makes, acknowledges, and files the following amendment to its Articles of Incorporation, pursuant to Section 607.1006, Florida Statutes.

FIRST: The Articles of Incorporation of GRACE COMMUNITY SCHOOL OF GOLDEN GATE III, INC., were filed with the Florida Department of State on January 2, 2003, and were assigned Document Number P03000000480.

SECOND: Article II of the Articles of Incorporation of GRACE COMMUNITY SCHOOL OF GOLDEN GATE III, INC., is hereby deleted in its entirety and replaced as follows:

The Corporation shall have the power to engage in religious worship and religious education.

The amendment was approved by the shareholders as of May 22, 2008, in an action by unanimous written consent without a meeting, in accordance with Section 607.0704, Florida Statutes. The unanimous written consent for the amendment was sufficient for approval.
