## ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

### ARTICLE I-NAME

The name of the corporation shall be: B. James W., Inc..

### ARTICLE II-NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

### ARTICLE III-TERM OF EXISTENCE

The corporation is to exist perpetually.

### ARTICLE IV-AUTHORIZED SHARES

The corporation shall have the authority to issue 10,000 shares of common capital stock with a par value of \$.01 per share.

### ARTICLE V-PREEMPTIVE RIGHTS

**ARTICLE XI-AMENDMENT**


