

The undersigned hereby adopts the following Articles of Incorporation for Maurene Pinto, Inc.
for the purpose of forming a Corporation under the laws of the State of Florida:

ARTICLE I - NAME

The corporation is to commence its corporate existence on the date of subscription
and acknowledgement of these Articles of Incorporation and shall perpetually exist
thereafter until dissolved sooner according to law.

ARTICLE III - PURPOSE
