

The undersigned incorporator, who is licensed to practice as a realtor in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and does hereby adopt the following Articles of Incorporation:

ARTICLE I Name of Corporation

The name of this corporation is MICHELLE CRABTREE, P.A.

ARTICLE II
Principal Office and Mailing Address

The principal office and mailing address of this corporation shall be 2512 Teal Avenue, Sarasota, Florida 34232.

ARTICLE III Purpose

The purpose of the corporation is to act as a real estate salesperson. The sole and exclusive professional service to be rendered by the corporation is the sale of real estate as a licensed realtor.
