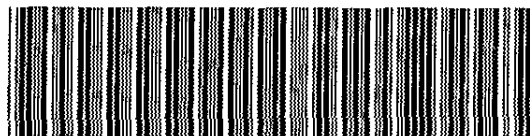

Articles of Incorporation  
of

The undersigned incorporator, who is licensed to practice as a realtor in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and does hereby adopt the following Articles of Incorporation:

ARTICLE I  
Name of Corporation

The name of this corporation is MICHELLE CRABTREE, P.A.

ARTICLE II  
Principal Office and Mailing Address

The principal office and mailing address of this corporation shall be 2512 Teal Avenue, Sarasota, Florida 34232.

ARTICLE III  
Purpose

The purpose of the corporation is to act as a real estate salesperson. The sole and exclusive professional service to be rendered by the corporation is the sale of real estate as a licensed realtor. However, this corporation may invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law, and may own real and personal

property necessary for the rendering of the professional service authorized hereby.

ARTICLE IV  
Capital Stock

The total number of shares of stock that the corporation is authorized to issue or have outstanding at any one time is One Thousand (1000) shares. These shares shall be of a single class of common stock, and shall be without par value.

ARTICLE V  
Duration and Effective Date

The corporation shall have perpetual existence. The effective date of the corporation shall be January 1, 2003 as provided by Florida Statutes.

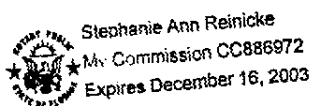
