On Friday, August 1, 2003, you and I had a conversation concerning a \$1200 late fee that I am being charged due to late filings on the annual reports for the following corporations: Knoxscape, Inc., Z Holdings, Inc., and Humpty Dumpster, Inc.

These three companies were filed for incorporation on 1/3/03 with an effective date of 12/31/02. When the original annual reports were received, I called your office and spoke to a representative (at the time I did not write down the name of the individual), and I was told that since the companies had been filed on 1/3/03, I did not have to worry about filing for them again.


You will note that six other companies for which I am the Chief Financial Officer were filed on time and always have been. The six other companies that I oversee are Auto Solution, U.S.A., Inc., Barbi Finance Corp., Barbara Motors, Inc., National Auto Lenders, Inc., Natural Encounters Fishing Charters, Inc., and Next Venture Partners LLC.

I was surprised to receive a second notice indicating requirement of filing with a penalty. I did not file for the three mentioned companies because I was instructed not to do so.

I have gone ahead and filled out the Annual Uniform Business Report for Knoxscape, Inc. and Z Holdings, Inc. with their respective annual fees. Humpty Dumpster, Inc. was filed on-line and paid with the delinquency fee by my assistant without my review. On this one I respectfully request a refund of the penalty. On the other two companies, I respectfully request a waiver of the delinquency fee.
