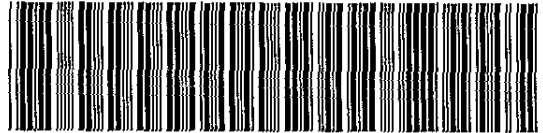

ARTICLE I: NAME
