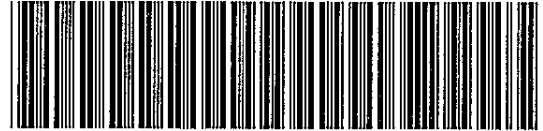

ARTICLE I - NAME AND PRINCIPAL ADDRESS
