#### **ARTICLES OF INCORPORATION**

The undersigned incorporators, natural persons competent to contract, hereby adopt the following Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes, the Florida Business Corporation Act.

#### ARTICLE I NAME
