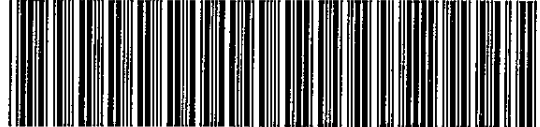

The power to alter, adopt, amend or repeal the by-laws shall be vested in the Board of Directors and the Shareholders of this corporation.


Article IX- Amendment to Articles of Incorporation

This corporation shall indemnify any officer or director, or any former officer or director, of this corporation to the fullest extent permitted by law.

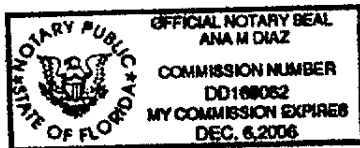




