#### ARTICLE 1 - NAME

The name of this corporation is RAH FINANCIAL SERVICES INC..

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this the filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE

### ARTICLE X - AMENDMENT
