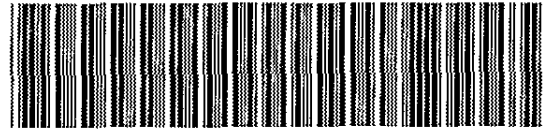

THE UNDERSIGNED, acting as sole incorporator of GTK, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be GTK, INC.

ARTICLE II

Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

ARTICLE III

Principal Office

The address of the Principal Office of the corporation is Greg Smith. The location of the Principal Office shall be subject to change as may be provided for in the bylaws duly adopted by the corporation.

Initial Board of Directors



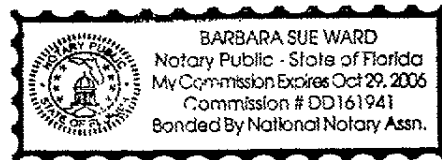
