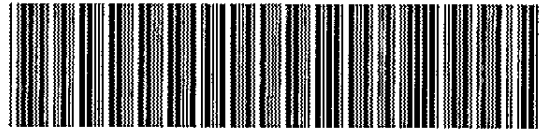

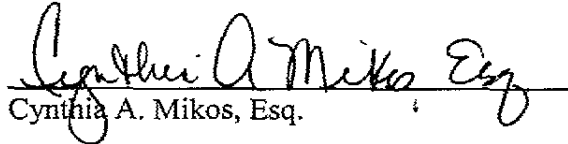

SHAREHOLDER'S AGREEMENT

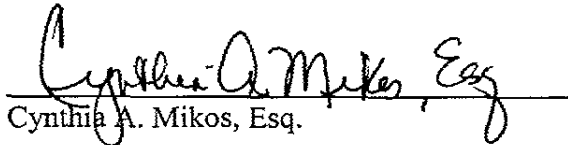
