ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is: ARTHUR'S CUSTOM TILE, INC. The corporate address is 5620 CONNELL ROAD, PLANT CITY, FL 33567.

Duration

The duration of the Corporation is perpetual.

Purpose

The general purposes for which the Corporation is organized are the following:
