OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is: ARTHUR'S CUSTOM TILE, INC.

Duration

The duration of the Corporation is perpetual.

ARTICLE III

Purpose


ARTICLE VII
