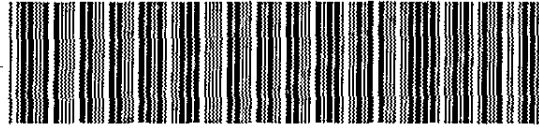

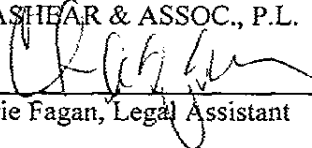

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
WORLDWIDE ELECTRONIC BUSINESS, COMPUTERS, INFORMATION,  
CONCEPTS AND SOLUTIONS, INC.

TO: Department of State  
Tallahassee, Florida 32304

Pursuant to the provisions in Section 607.1003 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation pursuant to a meeting of the shareholders of the Corporation duly called on March 10, 2003:

1. The following amendment to the Articles of Incorporation of Worldwide Electronic Business, Computers, Information, Concepts and Solutions, Inc. was adopted by holders of a majority of the outstanding shares of the common stock of the corporation on March 10, 2003, in the manner prescribed by the Florida General Corporation Act:

Article I

*Name.* The name of this Corporation is InteQuest, Inc.

2. The number of shares of the corporation outstanding at the time of such adoption was 510,000 shares common stock; and the number of shares entitled to vote thereon was 510,000 shares common stock.

3. The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

4. Number of shares voted for the amendment of Article I was 510,000; the number of shares voted against such amendment was 0; the number of shares abstaining was 0; and the number of shares not represented at the meeting in person or by proxy was 0.

5. The number of votes cast by a majority of the holders of common stock in favor of the amendment of Article I was sufficient for approval by the common stock shareholders.
