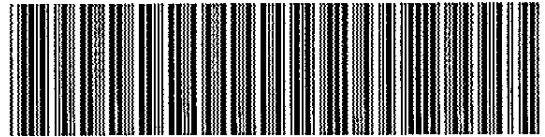


ARTICLE EIGHT. AMENDMENTS HERETO
