ARTICLE I.

NAME

The name of this Corporation shall be: GENERAL MANAGERS INTERNATIONAL, INC..

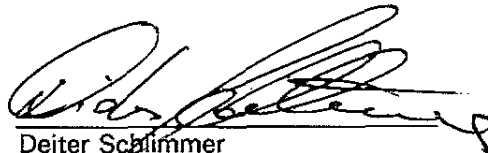
