

ARTICLES OF INCORPORATION OF EAGLE CREEK REMODELING, INC.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is EAGLE CREEK REMODELING, INC., and the principal address and principal place of business is 14126 WHISPERWOOD DRIVE, CLEARWATER, FLORIDA 33762.
