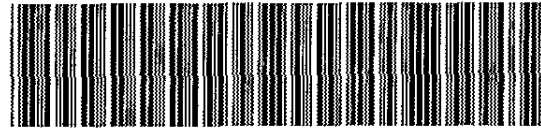



ARTICLES OF INCORPORATION

The undersigned natural person, competent and licensed to Practice in the state of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation shall be:

DUANY FAMILY PRACTICE, P.A.

## ARTICLE II. NATURE OF BUSINESS

The general nature and purpose of this business to be transacted, promoted and carried on by the corporation are as follows:

- A. To engage in every aspect in the practice of Medicine, and all its fields of specialization's, as are engaged by medical practitioners,
- B. To engage and render the professional services involved only through its officers, agents and employees who shall be medical practitioners in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.
- C. To invest its funds in real estate mortgages, stocks, bonds, and any other type of investment permitted by law.
- D. To engage in no other business other than the rendition of the professional services specified herein.
- E. To do everything necessary and proper in accomplishing the purpose herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida

## ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having \$1 par value per share. Shares of the corporation's stock and certificates shall be issued only to medical practitioners in good standing and duly licensees or

otherwise legally authorized within the State of Florida to render the same professional services as this corporation

#### ARTICLE IV. REGISTERED AGENT

The street address of the initial registered office of the Corporation shall be 2700 West Martin Luther King Blvd. Suite 310, Tampa, Florida 33607, and the name of the initial registered agent at said address is Anthony T Duany.

#### ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

#### ARTICLE VI. SPECIAL PROVISION

It is the intent of the Incorporator that the corporation may qualify as an S corporation under the Internal Revenue Code. Such actions as are necessary will be taken by the appropriate officers to accomplish this compliance.


