ARTICLES OF INCORPORATION OF NJS, II, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I

The name of the Corporation is NJS, II, Inc.
