ARTICLES OF INCORPORATION

of

SIRVANTI, INC.

We, the undersigned, do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be:

SIRVANTI, INC., a Florida corporation

ARTICLE II - PURPOSE

- A. To carry on and engage in the business of purchasing, selling, designing, manufacturing, repairing, and altering all types of men's clothing, including all accessories thereto and to also perform any other act which may be necessary and related thereto.
- B. To carry on and engage in any business or acrtivity which may be authorized and permitted under and by virtue of the laws of the United States of america or the State of Florida.

ARTICLE III - CAPITAL STOCK

The Corporation shall be authorized to issue capital stock in the following manner, to wit: FIFTY(50) Shares of Common Stock, having no par value.

ARTICLE IV - POWERS

The powers of the Corporation shall include all those conferred by the bylaws of the Corporation and the laws of the State of Florida.

<u>ARTICLE V - TERM OF EXISTENCE</u>

The Corporation shall have perpetual existence, in accordance with the laws of the State of Florida.

ARTICLE VI - PRINCIPAL PLACE OF BUSINESS

The principal place of business of the Corporation shall be:
