**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
TOTAL HOME HEALTH, INC.**

Pursuant to the requirements of the Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Amended and Restated Articles of Incorporation of Total Home Health, Inc. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on January 6, 2003.

ARTICLE I—NAME AND DURATION

The name of the Corporation shall be "Total Home Health, Inc." The duration of the Corporation is perpetual.

ARTICLE II—PRINCIPAL OFFICE

The street address of the principal office and the mailing address of the Corporation are 3121 W. Hallandale Beach Boulevard, Suite 101, Hallandale, Florida 33009.

ARTICLE III—REGISTERED OFFICE AND AGENT

The Registered Office of this Corporation shall be at 9999 Summerbreeze Drive, 419, Sunrise, Florida 33322 and the Registered Agent at such address shall be Sheldon Ramkisson.

ARTICLE IV—CORPORATE PURPOSES, POWERS, AND RIGHTS

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.

ARTICLE V—CAPITAL STOCK

The total number of shares of capital stock which the Corporation has the authority to issue is six hundred sixty-seven (667) shares of common stock ("Common Stock") all of which shall be of \$0.01 par value per share and each of which shall be issued fully paid and non assignable.

ARTICLE VI—EFFECTIVE DATE

The effective date of these Amended and Restated Articles will be as of the date of filing of these Amended and Restated Articles with the Department of State of the State of Florida.


