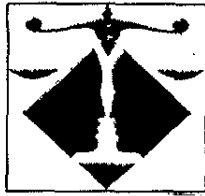

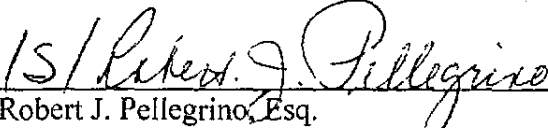
Enclosed please find their Articles of Amendment authorizing this change as well as ^A~~then~~ check payable to you in the amount of \$35.00.

OF

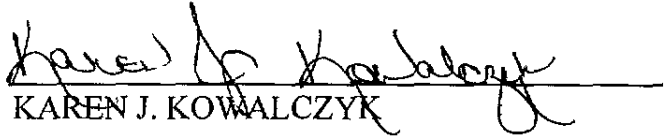

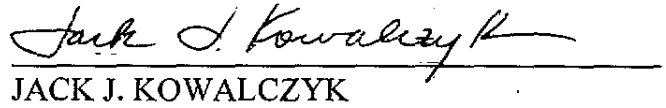

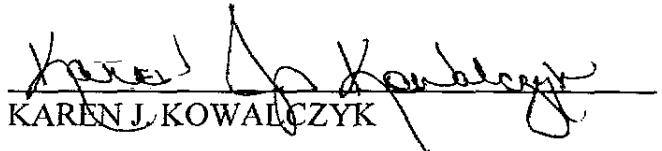
