

The undersigned subscriber of these ARTICLES OF INCORPORATION, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I - Name

The name of this corporation is **JOSHUA STUCCO, INC.**

Article II - Duration

This corporation shall exist perpetually, commencing upon filing.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Address

The initial principal place of business of this corporation is 3152 Bob Sikes Rd., DeFuniak Springs, FL 32433 and the mailing address of this corporation is 3152 Bob Sikes Rd., DeFuniak Springs, FL 32433.

Article V - Capital Stock

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock with a par value of \$1.00 per share.

Article VI - Preemptive Rights

This corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.


Article XII - Amendment




