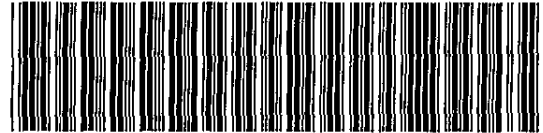

ARTICLE I - NAME

The name of this corporation is **FOGG REALTY, INC.-PHASE II.**

ARTICLE II - DURATION

The duration of this corporation shall commence on January 1, 2003 and shall be perpetual.
