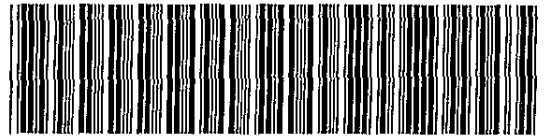

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation.

ARTICLE ONE

NAME

The name of the corporation is Carol M. Touhy, P.A.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The purpose for which the corporation is organized is to practice the profession of law and provide legal services.

DIRECTORS



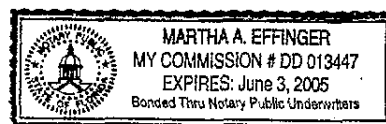


