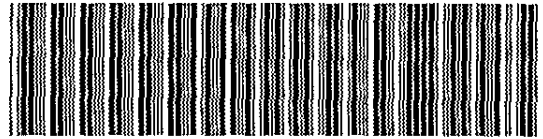

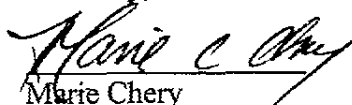

**NAME**

The name of the Corporation shall be

**ARTICLE II.**

**NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful, business or activities as permitted under the laws of the United States, State of Florida or any other State.

**ARTICLE III.**

**CAPITAL STOCK**
