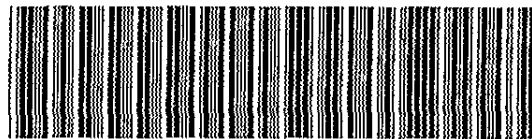

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation shall be Pacific Nuclear Specialist Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized to transact any lawful business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue one hundred (100) shares of common stock, which shall have a value of 1.00. The consideration to be paid for each share shall be payable in money, property or services at a just valuation to be fixed by the Board of Directors.

ARTICLE VII - BOARD OF DIRECTORS



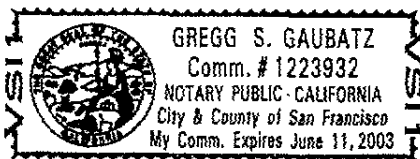


