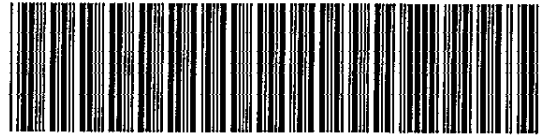

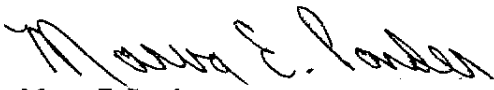

**We, the undersigned, as proper persons acting as incorporator of a corporation under the Laws of the State of Florida, adopt the following articles of incorporation:**

### **FIRST**
