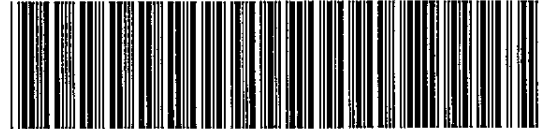

The undersigned incorporators of, Northgate Development of Bay County, Inc. hereby form a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

**ARTICLE I - NAME OF CORPORATION**

**ARTICLE II - TERM OF EXISTENCE**

This corporation shall exist perpetually unless dissolved according to law.

**ARTICLE III - GENERAL PURPOSE**




