ARTICLES OF INCORPORATION OF TRIBUTE PLACE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be:

ARTICLE II - PURPOSES/NATURE OF BUSINESS
