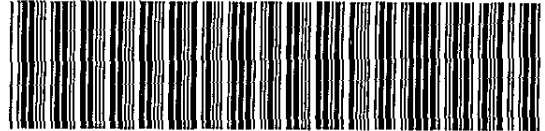

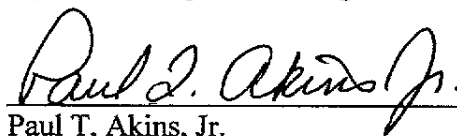
## **ARTICLE 9 - INDEMNIFICATION**
