No personal liability shall be imposed on the stockholders of the corporation for the debts of the corporation.

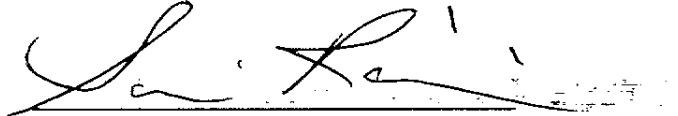
Article XI – Indemnification

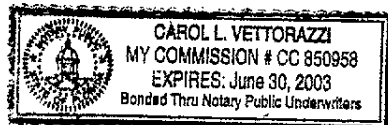

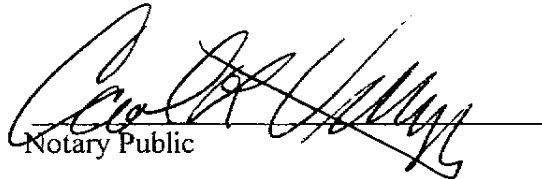

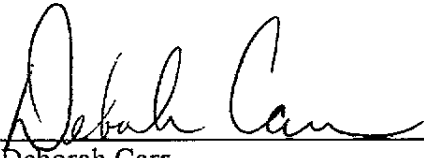
