ARTICLES OF INCORPORATION OF Israpost, Inc.

TALLAHASSLE FLORIDA

The undersigned subscriber to these articles of incorporation, being a natural person and competent to contract, hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of this Corporation is Israpost, Inc.
