THIS CORPORATION, is submitted for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities

ARTICLE I

The name of this corporation shall be HITCHCOCK PROPERTY SERVICES, INC.
