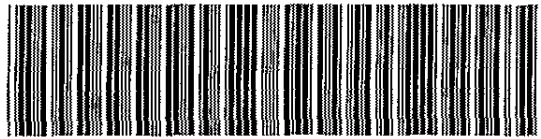

**ARTICLES OF INCORPORATION OF
AAA International Chiropractic Center, Inc.**

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such a corporation: SECRETARY OF STATE
TALLAHASSEE, FLORIDA

ARTICLE I

Name

The name of the corporation shall be **AAA International Chiropractic Center, Inc.**

ARTICLE II

Duration

The corporation shall have perpetual existence.

ARTICLE III

Purpose

The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and of Florida.

ARTICLE IV

Capital Stock

The corporation is authorized to issue 1,000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR PER SHARE. The corporation is authorized to issue only one type of stock.

ARTICLE V

Initial Registered Office and Agent

Informal Action of Directors


If all of the directors severally or collectively consent in writing to any action take or to

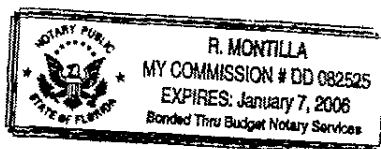
