ARTICLES OF INCORPORATION

OF

FTO SERVICES, INC.

The undersigned, acting as the incorporator of the Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I NAME OF THE CORPORATION

The name of this Corporation shall be FTO Services, Inc.

ARTICLE II PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III

The Corporation is organized for the purpose of the sale of a variety of financial service and telecommunications products to business and engaging in any other activity or business permitted under the laws of the United States and of this State.

ARTICLE IV AUTHORIZED SHARES

Number: The aggregate number of shares that the Corporation shall have the authority to issue Ten Thousand (10,000) shares of Capital Stock.

issue: One Hundred (100) shares of the Capital Voting Stock of the Corporation shall be issued for adequate consideration in the following manner:

51 Shares to Louise A. Radomsky 49 Shares to Joseph W. Radomsky

Dividends: The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the Corporation, or in such other manner agreed to by the Shareholders.

Classes of Stock: The shares of the Corporation may be divided into classes.

ARTICLE V REGISTERED OFFICE AND AGENT

The street address in Florida of the initial registered office of the Corporation is 1534 St. Edmunds Place, Heathrow, Florida 32746, and the name of the initial registered agent at said address is Joseph W. Radomsky.

ARTICLE VI PRINCIPAL OFFICE

The Principal Office of the corporation shall be 1534 St. Edmunds Place, Heathrow, Florida 32746.

ARTICLE VII BOARD OF DIRECTORS

This corporation shall have two (2) Directors constituting the initial Board of Directors. The Directors need not be a residents of the State of Florida or Shareholders of the Corporation. Majority vote of the Board of Directors is required to constitute a quorum for the transaction of business. Only a majority act of the Directors shall constitute

The preemptive rights of any holder is determined by the ratio of the authorized shares of common stock held by the holder to all shares of common stock currently authorized.
