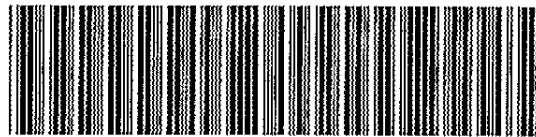

ARTICLE I

NAME

The name of this Corporation is A & L ADVANCED BLIND & WINDOW CLEANING INC.

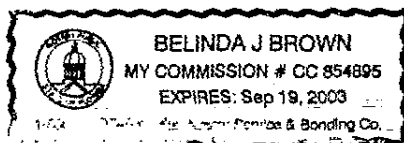
