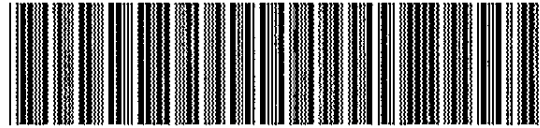

Pursuant to Section 607.1003 of the Florida Business Corporation Act, Mad Science of Tampa Bay, Inc., adopts these Articles of Amendment:

FIRST: The name of the corporation is Mad Science of Tampa Bay, Inc.;

SECOND: Article I of the corporation's Articles of Incorporation is amended entirely to read as follows:

The name of the corporation is "Schneider, Inc."

THIRD: The foregoing amendment to Article I was adopted and approved on behalf of the sole shareholder of the common stock of the corporation on April 29th, 2004, by written consent without a meeting. The sole shareholder holds a sufficient number of votes to approve the amendment.
