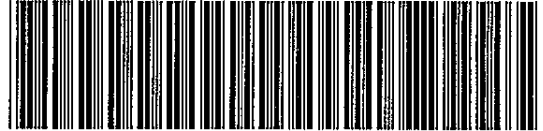

The undersigned, acting as the incorporator of Mad Science of Tampa Bay, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.




