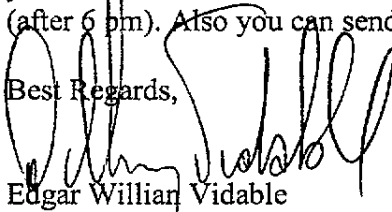
- Please be so kind of re-enter the document Articles Of Incorporation for PowerPrise Corp. that you will find attached to this letter. As you may know I already paid the fee
