These Articles of Dissolution are filed pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, and provide as follows:

1. The name of the corporation is **ARGO CARGO, INC.** (the "Corporation").
2. The Corporation was formed in the State of Florida effective January 9, 2003, under Document No. P03000003269.
3. The dissolution of the Corporation was authorized by the Shareholders and the Directors of the Corporation by a unanimous written consent dated as of August 11, 2010. The number of votes cast for dissolution was sufficient for approval.
4. The net assets of the Corporation remaining after the winding-up of the Corporation have been distributed to the shareholders of record.
