ARTICLES OF INCORPORATION OF DESIGNER CLOSETS PLUS, INC.

In compliance with the requirements of P.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Designer Closets Plus, Inc.

ARTICLE II

The existence of the corporation shall begin on January 10, 2003.
