
ARTICLE VIII. AMENDED

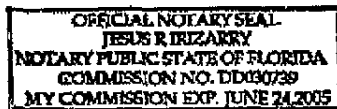


