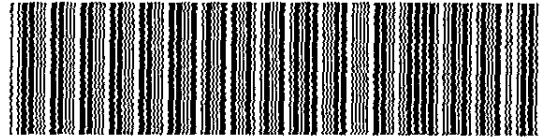

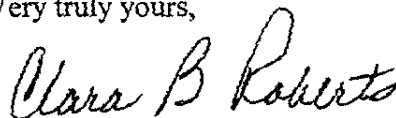

The Corporation shall have the authority to issue 100 shares of common stock, par value \$0.01 per share.

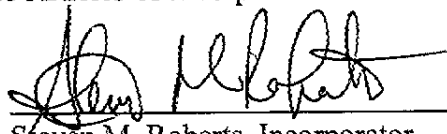
