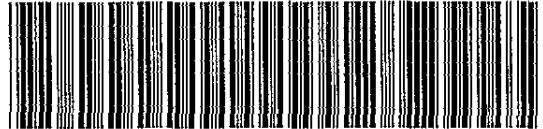

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE ONE

NAME

The name of the Corporation is PRO TECH PAINT AND BODY, INC.

## ARTICLE TWO

DURATION

The term of existence of the Corporation is perpetual.

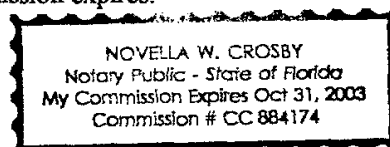
