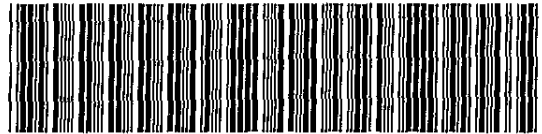

Article I – Name

The name of the corporation is: Aerocomp Racing, Inc.

Article II – Duration

This corporation shall exist perpetually.


