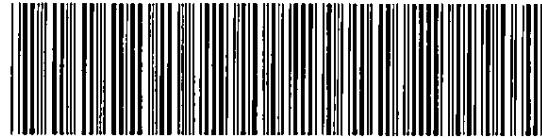

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "FBCA"), USA Tax & Insurance Services Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

**ARTICLE I**

**Name**

The name of the Corporation is USA Tax & Insurance Services Inc.

**ARTICLE II**

**Amendment to the Articles of Incorporation**

Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced to read as follows:

**"ARTICLE I.**

**Name**

The name of the corporation (hereinafter referred to as the "Corporation") is Hand Tax Advisory Group, Inc."

**ARTICLE III**

**Date of Adoption**

This amendment to the Articles of Incorporation of the Corporation (the "Amendment") was adopted on the 30th day of October, 2019.

**ARTICLE IV**
